# TRANSPORTATION

Transportation is an important factor for any family that is considering sending their child to the Orleans County Christian School.

If you wish to secure public transportation for your child, you must contact your local school district with a written request for transportation before April 1st.

We have been advised by the school district to instruct parents to submit transportation requests even if they are uncertain about their decision to send their child to OCCS. In the event that your child does not attend the school, the request can always be rescinded.

Those who live outside of the Medina School District should contact their local district to discuss transportation eligibility. New York State regulations are very specific regarding transportation to private schools and the district will be able to help you.
